★ Message from IDVA Director Terry Prince

Wow! Are we really at the end of 2025? Looking back on the past year, we are proud to once again have made history in the State of Illinois for our treasured veterans when we opened our new Veterans' Home in Quincy, Illinois. This fantastic example of engineering and a \$300 million investment immediately enhanced the lives of its residents and our IDVA staff who are delivering extraordinary care. The project included an independent living building where we can house up to 88 veterans in studio and one-bedroom

apartments, along with the long-term care building for 288 residents. Governor Pritzker visited the Home for the official ribbon-cutting ceremony, where the residents, staff, and community celebrated. It's a momentous occasion when a state opens a new Veterans' Home, and in the past two and a half years, Illinois opened two homes, one in Chicago and the buildings in Quincy. This is a testament to Illinois' commitment to the quality of care for its veterans.

This year, IDVA has advocated strongly for Illinois veterans. While these numbers reflect our fiscal year, July 1st through June 30th, they represent the transformative impact the team has had on Illinois veterans. Our VSOs conducted over 19,000 in-person and nearly 45,000 telephone interviews. These interactions resulted in providing direction, information, and preparation of 18,000 state and federal benefit applications.

If you are out and about at special events, you may have visited one of our VSOs who attended over 300 events across the state. We are growing the Field Services team by hiring additional Veterans Service Officers and outreach coordinators who will continue to get out into the community and find the veterans, where they live and work.

The Veterans Cash Lottery Grant program disbursed nearly \$1.2 million in funding for veterans' programs addressing concerns, including PTSD, homelessness, and job training.

Our program's teams offered a wide variety of events for Gold Star Families, Remembrance Day ceremonies, Veterans' Day at the State Fair, and the 250th birthday of the United States Marine Corps, U.S. Army and U.S. Navy. Also, 25 women veterans were honored in the inaugural class of "25 Women Veterans in 2025."

Our goal is to inform veterans about services, benefits, and programs that support them while also sharing the important events and work taking place across the Agency. We enter 2026 energized to continue building on our successful efforts and innovating new and better ways to serve veterans. It is our privilege and passion to serve veterans, in our continuing mission to ensure veterans thrive in Illinois.

Happy Holidays and may the New Year bring and you and your family many blessings.

Field Services is growing its team of Veteran Service Officers (VSOs) to broaden its reach to veterans across Illinois. It has recruited, hired, and trained veterans who are poised and eager to guide other veterans in obtaining their earned benefits. They complete rigorous training to learn about available benefits and the claims process to position themselves to support veterans at the highest level. As veterans, they can relate to the many challenges of transitioning from military service and uncovering what is possible from education to health care to employment and beyond.
